Agricultural Business Agreement

Applicant agrees to pay The McGregor Company the "Amount Due" shown on each monthly statement (except for merchandise sold on a "deferred basis") by the 10th of the month following billing. If not paid by the 10th of the month following billing, the account will be considered past due. The applicant agrees to pay a FINANCE CHARGE (\$1.00 minimum) which will be computed by applying the PERIODIC RATE OF 1½% per month (ANNUAL PERCENTAGE RATE IS 18%) to the prior month end balance less payments. All payments will be applied first to the Prior Unpaid FINANCE CHARGES and any past due balances. Seller reserves the right to discontinue sales or service on any past due account. Seller reserves the right to claim a crop lien as provided by local law and applicant's consent to such lien.

I/we authorize The McGregor Company or any credit reporting agency to investigate any data obtained from me pertaining to my/our creditworthiness. I authorize any entity having relevant information concerning my/our creditworthiness to release said information or copies of pertinent documents, including but not limited to financial statements, operating budgets, financing statements, and security agreements to The McGregor Company.

Should any party employ an attorney for the purpose of enforcing this agreement, or any judgment based on this agreement, the prevailing party shall be entitled to receive from the other party reimbursement for all attorney's fees and all costs whether or not such reimbursement shall be included in any judgment or final order issued in that proceeding. Any suit brought by seller, at the option of the seller, may be laid in Whitman County, Washington. In the event of default and hiring of a third party collector, the customer will be responsible for paying the collection agency fees up to, but not exceeding, 35% of the debt.
